THIS COURT ORDERS THAT:

- 1. The Applicant cannot cease to pay spousal support unilaterally.
- 2. The Applicant shall continue to pay spousal support to the Respondent in accordance with the Final Order of Justice Lemon dated October 25, 2013. It is noted that the operative paragraph of that said Final Order is paragraph 27, which contemplates a recalculation of spousal support on the basis of the Respondent's actual income or \$30,000.00.
- 3. Recognizing that the parties have been unable to reach an agreement on the "paragraph 27" calculation, the Applicant shall pay spousal support to the Respondent on an interim, without prejudice basis in the amount of \$748.00 per month, commencing June 1, 2015 and on every first day of the month thereafter, based on the Applicant's 2014 income of \$92,882.00 and the Respondent's income imputed at \$30,000.00.

- 4. Both parties shall comply with all other aspects of the Final Order of Justice Lemon dated October 25, 2013 as they relate to their respective disclosure obligations.
- 5. The Applicant shall pay costs in favour of the Respondent fixed at \$8,000.00 payable in up to 4 installments over the next 6 months from the date of this Order.
- 6. Unless the support order is withdrawn from the Office of the Director of the Family Responsibility Office, it shall be enforced by the Director, and amounts owing under the support order shall be paid to the Director, who shall pay them to the person to whom they are owed.
- 7. This order bears post-judgment interest at the rate of _____% per year effective from the date of this order. Where there is default in payment, the payment in default shall bear interest only from the date of default.
